*Classes are run under British Dressage rules. Rosettes to 6<sup>th</sup> place. Special rosette to highest placed Connemara in each class.  
Entry fees: £14 (BCPS and SE Fell members), £17 (non-members).*

SECTIONS A-F are qualifiers for NPS Supreme Dressage Championship Final at Addington Manor Equ.Centre 6/4/19.  
The two highest placed ponies in classes 3 & 5 run under BD rules will qualify for 2019 final and be chosen to represent their Breed, NPS Area or other team in the Team Challenge which will be incorporated into the 2019 Championship Final which is run under NPS rules and are available to all NPS Dressage and Showing members.
