The fee for pure bred fillies and colts includes a compulsory HWSO test fee of £25.00. If both of the foal's parents have already been tested for HWSO and their results are N/N please contact the office. Provided the HWSO samples have been taken by a vet and copies of the certificates have been lodged against the ponies records on the database, there is no requirement for the foal to be tested for HWSO in this case and the £25 HWSO fee will not be payable.

The fee for part bred fillies and colts does not include a HWSO test. It is, however, recommended that the HWSO status of the Connemara side of the pedigree is researched before breeding.

**Registration fee includes charge for DNA processing. Late Registration Fee of £25 will apply to foals registered either after 31<sup>st</sup> December in their year of birth or after the age of 6 Months, whichever is the later date.**
