ISSUE OF DUPLICATE CONNEMARA PONY BREEDERS' SOCIETY PASSPORT

Please read the following notes before completing the application

The BCPS are now required to issue duplicate CPBS passports for those pure-bred Connemara ponies, originally registered in Ireland, but now resident in the Great Britain

The BCPS is required to follow the CPBS requirements for issuing these duplicate passports which are as follows:-

- 1. All **CPBS** Duplicate Passport applications must be verified by DNA, microchip and marking chart which will extend the **timeline of application to 8 10 weeks** due to the length of time Weatherbys Scientific Laboratory takes to process the DNA there is nothing the BCPS can do to speed this up.
- 2. A fee of £200 (BCPS Members £150) must be enclosed with this form (or BACS/ Paypal details below) and sent to the BCPS prior to the Society's undertaking to issue the pony with a Duplicate Document of Identification (Passport).
- 3. A DNA sampling kit and BCPS Marking/Silhouette Form will be issued to the owner on receipt of the correct fee.
- 4. If you are not the registered owner of the pony, Section 4 of this form must be completed and the relevant fee for Transfer of Ownership paid.
- 5. A hair sample taken and authorised by a veterinary surgeon must be sent to the BCPS so it can be forwarded to Weatherbys Scientific Laboratory for analysis to confirm that the pony to be issued with the duplicate document matches the DNA profile from the original sample **of the relevant pony** on record.
- 6. A new BCPS Markings/Silhouette Form must be completed by your vet.
- 7. Only BCPS Markings/Silhouette Forms will be accepted. Applications accompanied by any other markings forms will be returned.
- 8. A duplicate document will not be issued by the BCPS unless these conditions are complied with fully.
- 9. If any information required is missing or incomplete, this application will be returned.
